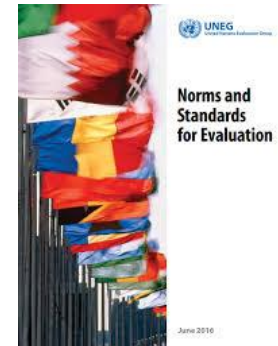


4) Executive Certificate Programme on Evaluation and Sustainable Development Goals

- fee-based, executive educational programme leading to an **Executive Certificate** awarded by:
- possibility of obtaining academic credits & recognition by professional evaluation associations and networks explored.
- programme would comprise **six to eight** modules, including
 - two modules on the 2030 Agenda and the global indicator framework;
 - two-four modules on evaluation; and
 - two modules on key skills competencies (e.g. leadership and management skills for evaluators (and commissioners of evaluation))

MANAGEMENT



- Replicate Bangkok workshop: at **national** level, in other **regions or sub-regions**, including the **Pacific Island countries and Africa**.
- Abuja learning conference: Plans to develop a **French-speaking curriculum** for a similar event to take place in Lomé, Togo, are underway (September 2017); as well as for a **Spanish-speaking event** in Bogota, Colombia (November 2017).
- **Executive Certificate Programme:** mobilise partners, disseminate to potential participants
